

The Florida Department of Transportation (FDOT), District One, invites you to attend a public hearing to learn about the proposed intersection improvement project on State Road (SR) 555 (US 17) from south of Spirit Lake Road to north of Spirit Lake Road in Polk County, Florida. The purpose of this project is to reconstruct the existing asphalt pavement with rigid concrete pavement within the limits of SR 555 (US 17) at the Spirit Lake Road intersection. The scope also includes closing an existing median opening, resurfacing, adding sidewalk to connect the Bartow Municipal Airport entrance with Bomber Road, transit pads, new signalization at Spirit Lake Road, signing and pavement marking upgrades and intersection lighting. The public hearing will be held on Tuesday, November 17, 2020, and will consist of a hybrid format with combined face-to-face and virtual components. The public is invited to participate in the hearing virtually, or visit the public viewing location at 2201 Old Bartow Eagle Lake Road, Bartow, FL 33830. An open house will begin at 5:30 p.m., where attendees may review project displays and speak with project team members. The formal portion of the hearing will begin at 6 p.m., and will include an opportunity for attendees to make public comments. Following the formal portion of the hearing, the informal open house will resume and continue until 7 p.m.

A court reporter will be available to receive comments in a one-on-one setting before and after the formal portion of the hearing. 


## ACCESS MANAGEMENT

Conflict points are locations along a roadway where two vehicle's paths can legally cross. At a four-way intersection, there are as many as 36 conflict points.

Each conflict point is a location where a crash can occur. A basic principle of access management is to limit the number of conflict points along a roadway by minimizing the number of driveways and median openings and restricting certain movements at some median openings. Drivers can be overwhelmed by conflict points in close proximity to one another, increasing the potential for crashes. Good access management practice strives to separate conflict points by providing a reasonable distance between driveways.
