## Public Hearing Scheduled – December 5, 2023

### ABOUT THE PROJECT

The Florida Department of Transportation (FDOT), District One, previously completed a PD&E, or Project Development & Environment, Study for Harborview Road in October, 2019. This study evaluated and documented the benefits, costs, and impacts of widening Harborview Road from the existing two-lane undivided roadway to a four-lane divided highway. These improvements are intended to address the projected number of vehicles that will be generated by future population and economic growth. The current design has changed from what was prepared during the original PD&E Study. This has resulted in changes to proposed right-of-way impacts.

The FDOT invites you to the Harborview Road PD&E Re-evaluation public hearing on Tuesday, December 5, 2023. FDOT is preparing final design plans for this project. The public hearing is held to present information about the changes in design since completion of the PD&E Study. This hearing will also provide information on the re-evaluation of the engineering and environmental analysis completed to date and will provide the opportunity for the public to offer feedback for the official hearing record. For your convenience, FDOT is providing three ways to participate. You can participate live online or in-person. The information presented during either format will be the same and all attendees will have opportunity to comment.

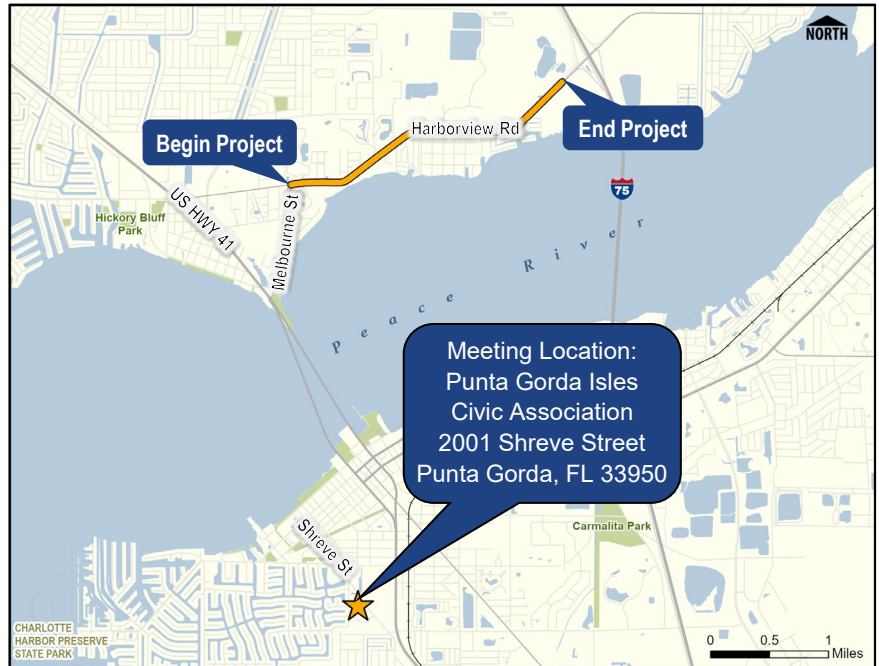
