The Florida Department of Transportation (FDOT) is preparing design plans for the Cortez Road bridge replacement from SR 789 (Gulf Drive) in Bradenton Beach to 123<sup>rd</sup> Street West in Cortez. The existing bridge (a movable bascule span) was constructed in 1956 with an intended design life of 50 years and has had ongoing maintenance and repairs over the past 20 years to keep the bridge safe and operable. Despite these repairs, the bridge continues to have low sufficiency ratings and it remains functionally obsolete.

A Project Development and Environment (PD&E) Study was completed from 2013 through 2019 to evaluate potential bridge replacement alternatives along with the "no build" alternative. The study recommended that the high-level bridge replacement alternative move forward into design. The design phase began in October 2019. The Bridge Aesthetics Committee was created, consisting of 11 members representing local stakeholders. To date, the BAC has met nine times.

An in-person public meeting was held on January 31, 2023 to provide the public the opportunity to review project materials, hold one-on-one conversations with the project team, and to share input. The same meeting materials were available virtually (through the project website at <u>www.swflroads.com/project/430204-2</u>) from January 24, 2023 through February 10, 2023. This summary provides the highlights of the notification process, information shared at the public meeting, received comments, and the next steps.

# **Comments Received**

While comments are encouraged throughout the design project, comments received from January 4, 2023 (beginning of the meeting notification process) through February 10, 2023 (last day of the meeting comment period) are included in this meeting summary. Fifty-eight (58) individuals submitted written comments either by using comments forms or sending emails. A member of the project team provided written responses to all comments submitted during this time.

The following description summarizes the comments that were shared. The number in parenthesis indicates the number of times a comment was made. Note that the number in parenthesis does not match the number of submitted comments as several different topics often were covered in one submittal.

- Would have selected different lighting (1)

  - Keep character of Cortez Village (1)
- Suggest having a slightly different alignment by having Cortez Road go directly across to avoid elevation and reducing access on the east end (1)
- Create "bus only lane" on new bridge, which could also be used by small Electric Vehicles, like golf carts (1)
- Likes the enhanced multi-column pier and cheek walls (1)
- Likes the 4 overlooks and "wave" pattern (1)
- Need to limit bridge lighting pollution; consider function first followed by light pollution and aesthetics (1)
- Make the pedestrian/bike lane adjacent to Bridgeport Condos (under bridge) as wide as possible (1)
- Place 10-foot pedestrian/bike multi-use path on north side of bridge approach, west of 125<sup>th</sup> Street (1)
  - Facilitate access from south side of Cortez Road to north side to access bridge (1)
  - Helps eliminate need to cross Cortez Road (1)

    - Cortez residents, west of the fire station will be able to get home
    - Help emergency services in Cortez, Anna Maria Island, and Longboat Key
    - Avoids the nightmare during construction of the new Cortez Bridge
    - Existing bridge lifespan will be extended by having less traffic, including fewer heavy vehicles
    - Signage to protect Cortez businesses
    - Avoids changing the look of Cortez
    - Make east end part of the causeway
    - Impacts to FISH would be offset by less pollution with less "stop and go" traffic
      - Have roundabouts at both ends
- Consider another option for Anna Maria bridge by extending the existing causeway with a small section of tunnel (1)
- Put parking on the mainland and have a ferry shuttle between mainland and baches (1)

#### **Next Steps**

This public input has been shared with the project team for consideration as design continues. It is anticipated that 90% design plans will be submitted in Summer 2023 with final design plans to be submitted in Spring 2025. It is anticipated that construction will begin in late 2025 or early 2026.
