PROJECT OVERVIEW

FDOT has identified the need for safety improvements at SR 684 (Cortez Rd W) at Royal Palm Drive in Bradenton, Manatee County.

This project proposes a traffic signal and permanent median modifications to reduce conflict points and improve safety for SR 684 (Cortez Rd W) at Royal Palm Drive. This signal will include a pedestrian crossing to cross Cortez Road. With the new traffic signal, access to 102^{nd} Street West and 101^{st} Street West/Valeria Avenue will be affected by the signal and the turn lane improvements. PROPOSED DESIGN IMPROVEMENTS

- Traffic signal at Royal Palm Drive with eastbound/westbound protected-permissive left turn movements (flashing yellow arrows)
- · Signalized pedestrian crossings
- Eastbound and westbound left turn lanes extended with raised traffic separators
- Raised pedestrian refuge/directional island at 101st Street W/Valeria Avenue
- Current Status: 60% design
- Construction Summer 2025
