

The purpose of this project is to identify feasible corridor alternatives to connect the Cities of Bradenton and Palmetto across the Manatee River, improving regional multimodal mobility, connectivity, and safety for all users, including motorists, bicyclists, pedestrians, trucks, and transit. The identified corridors will be further evaluated through a Project Development and Environment (PD&E) study.

You can participate in the public meeting online or in-person. The same material will be displayed at both the in-person and online meetings and will be posted on the project website.

PROJECT GOALS

- Evaluate additional capacity and transportation demand across the Manatee River as part of the regional transportation system.
- Enhance safety and multi-modal interrelationships.
